

What Is the FP2030 Commitments Toolkit?

- Articulates the value of making an FP2030 commitment
- Provides best practices to strengthen the ownership and content of commitments
- Outlines recommended steps for making and launching a commitment
- Provides recommendations to foster and strengthen accountability



During this step you will draft your country's 2030 commitment. Your commitment should include a vision statement, commitment objectives, and strategies to achieve these objectives. Please refer to the government commitment form and the resources for incorporating rights-based family planning approaches throughout this step.

CREATE YOUR 2030 VISION STATEMENT

Your commitment vision statement outlines your government's high-level aspirations. By advancing family planning, what are the changes you hope to bring about in the lives of your population. with women and girls at the center, by 2030? The following recommendations may be helpful as you write your vision


- · This shared vision should energize and motivate family planning stakeholders throughout your country and globally to take collective action to achieve the progress you envision.
- · Your vision should be ambitious, creative, and forward-thinking. Strong vision statements are also clear and succinct-about 2-3 sentences long, or about 40 words—though yours can be as long as is needed to effectively communicate your vision.
- . If 2030 is not a relevant "horizon" for your vision statement, please feel free to use an end date that better fits your plans
- · Where relevant, include language from other government commitments or frameworks (e.g., SDGs, ICPD, GFF, national strategic plan) to build this vision statement. This will help
- · Finally, keep in mind that your consultation activities should focus primarily on your government's commitment objectives, not on the vision statement. Creating a 2030 vision statement should therefore be a fairly swift process.

How Is This Different from Previous Guidance?

Reflects the country-led and country-driven mandate of the new partnership

includes a strong focus on inclusion, transparency, and accountability.

Seeks to strengthen accountability within the commitments process for all governments, as well as donors and other partners


Requests that commitments be launched locally and then celebrated at global and regional levels

Continues to be anchored in data and rights-based principles


Key Principles



- Commitments should be **based in rights.** A commitment should be developed and validated through **an inclusive, equitable**, and **transparent** process that is rooted in rights-based family planning principles.
- Commitments should align with a country's other global and regional partnerships and objectives.
- Commitments should be grounded in available data and evidence.

March 2021 FP2030 COMMITMENTS 9

What Should a Commitment to FP2030 Include?



- A vision statement describing changes your country hopes to bring about in the lives of your population through this commitment by 2030, with women and girls at the center
- Commitment objectives that will contribute to the achievement of your vision and align with the partnership's five focus areas
- An accountability approach describing how your government and its partners will work together to ensure sustained and transparent progress toward commitment objectives

What Does the Accountability Guidance Include?



Recommended framing for a mutual accountability approach where governments, in collaboration with key stakeholders, are obligated to deliver on their commitments, and civil society is galvanized to support implementation of action plans and monitor progress toward achieving the commitments

What Does the Thematic Guidance Include?



- Briefs providing context and recommendations on including key themes in commitments, including:
 - Domestic financing
 - Emergency preparedness, response, and resilience
 - Postpartum family planning, postabortion family planning, and family planningimmunization integration
 - Supply chain strengthening
 - Youth and adolescence

Nine Steps to Consider in Making a Commitment



STEP ONE

Identify key stakeholders and create a stakeholder engagement plan



STEP FOUR

Review previous commitment progress (if applicable)



STEP SEVEN

Share draft commitment for feedback



STEP TWO

Secure buy in from key decision makers



STEP FIVE

Draft a vision statement and set objectives



STEP EIGHT

Finalize, validate, and share commitment



STEP THREE

Develop a comprehensive commitment process roadmap



STEP SIX

Define a country commitment accountability approach



STEP NINE

Launch commitment locally and amplify globally



Four Types of Engagement for Non-Governmental Stakeholders


As key national and global commitment makers

As part of national accountability mechanisms

As recipients of financial and technical support leveraged from partners by FP2030

As technical experts providing feedback on key aspects of government and other commitments

A Word on Donor Government Commitments



- FP2030 is currently working with the Kaiser Family Foundation to develop guidance for donor governments.
- Recommended elements of donor government commitments:
 - SMART and actionable content
 - An inclusive and transparent process for development, implementation and accountability
 - Aligned with existing national and global Frameworks
- Accountability approach centered on annual self reporting and global learning

A Closer Look at SMART Commitments for Donor Governments



Based on the FP2020 lessons learned on commitment tracking and accountability, we recommend donors include the following information as they develop their commitments:

- A baseline representing the donor's current investment in bilateral assistance for SRHR, and within that, family planning specifically
- The amount and expected time period for which the donor is committing to funding for sexual and reproductive rights, and a clear articulation whether the financial commitment represents sustained funding at existing levels or new and/or additional funding for SRHR
- Whether the new and/or additional funding amounts represent an annual amount of funding, or an amount over a specified time period, and if so, what that time period is
- The priority or targeted countries and whether the commitment is focused on priority populations or program areas

Nine Steps to Consider in Making a Commitment



STEP ONE

Organizational review of goals and potential engagement with FP2030



STEP FOUR

Detailed review of the resources and guidance in toolkit



STEP SEVEN

Submission to FP2030 for feedback



STEP TWO

Organization-led consultation and outreach to relevant partners



STEP FIVE

Drafting of commitment, in consultation with relevant partners



STEP EIGHT

Finalization of commitment



STEP THREE

Outreach to FP2030 to signal interest



STEP SIX

Review non-state partner commitment checklist



STEP NINE

Formal launch of commitment in coordination with FP2030 where possible

March 2021 FP2030 COMMITMENTS

Accountability Approach For Non-Governmental Commitment Makers

Annual Progress Monitoring

- Commitment makers pledge to participate in an annual self reporting process
- Commitment makers will be invited to participate in an annual streamlined, focused self reporting process.

Opportunities for Learning

- Ongoing opportunities to participate in media and other events and to capture insights from non-state partners in key FP2030 publications
- We welcome partners' ideas on desired opportunities for further engagement with FP2030

fP2030 Commitments

Key Metrics to be Captured in Annual Self-Reports



Quantitative review of existing commitment and progress made against key indicators over the year:

- Money disbursed
- Geographic areas covered
- Clients reached with services, advocacy messages, etc.

Qualitative capture of the value of partnership, lessons learned, and how to improve collaboration:

- Coordination, collaboration, or innovation facilitated by the partnership
- How can FP2030 help you achieve success against your commitment?
- Personal or organizational success stories

Background

Collaboration

DepEd and DOH formed a core group & committees starting March 2019

Teenage pregnancy concern was raised during the 34th Cabinet Meeting on February 06, 2019 which led to a directive to convene a summit

Pre-summit dialogues – FGDs/consultations were conducted from May to July 2019:

- a) Learners and Parents
- b) Key Implementers
- c) Faith-based Organization
- d) Civil Society Organizations
- e) Young People

DepEd and DOH held the national summit entitled, "Kapit-Kamay: Empowering the Youth to Make Informed Choices" on August 22, 2019





Department of Health and Department of Education Collaboration for FP2030

2019 Declaration on Addressing the Education, Health and Development Issues of Early Pregnancy

- •The physical, mental, and social well-being of adolescents is essential, and the promotion of their rights, protection, and safety requires multi-sectoral action toward a free, empowered, and harmonious society.
- •The issue of adolescent pregnancy is most urgent given its impact on individuals, families, communities, and the nation.
- •The persistently high numbers of adolescent pregnancies connect the health, education, and economic development; hence, the importance of addressing all three areas.
- •The assembly recognizes the importance of education completion as a robust protective factor in addressing adolescent pregnancies, especially among girls; of health information and services to enable adolescents to make informed decisions and practice healthy behaviors; and of economic development, which will provide



DOH and DepEd Collaboration for FP2030: Lessons learned

- Joint Initiative like "Kapit-kamay" addresses the fragmentation of adolescent programs to advance and prevent teen pregnancies.
- Understanding the roles and responsibilities of two agencies leads to complementation from policies, programs, and services.
- Resource and knowledge sharing with stakeholders advance the promotion of comprehensive sexuality education and teen pregnancy prevention.
- Youth engagement and shared vision with adolescent groups will help mainstream reproductive health programs in schools and communities.



DOH and DepEd collaboration's next steps

- Fully implementing age-appropriate and culturally sensitive Comprehensive Sexuality Education (CSE)
- Scaling up of adolescent-friendly health services
- Encouraging genuine participation of adolescents in the development of policies and programs
- Guaranteeing that all adolescents complete school, especially girls
- Ensuring that adolescents have decent and competitive economic opportunities after school completion
- Protecting adolescents from sexual violence, discrimination and harmful practices

- Implementing better support systems for pregnant adolescents and adolescent parents
- Strengthening family relationships, building a caring and nurturing community and society, and implementing family development programs, especially those geared towards men
- Supporting more researches and improving available data on adolescent pregnancy and its determinants
- Maximizing various media platforms to communicate key messages to generate multi-stakeholder engagement to accelerate reduction of adolescent pregnancies in the country
