## Conclusion

FP2030 commits to ensuring that adolescents and youth are equipped to make informed decisions about their sexual and reproductive health, supported by a dynamic and responsive ecosystem that prioritizes their needs and rights. Through innovative service delivery, data-driven strategies, prioritization of policies that center on adolescents and youth. championing youth leadership, and sustainable partnerships, we aim to significantly reduce unintended pregnancies and the unmet need for family planning, and to enhance the overall wellbeing of adolescents and youth worldwide.







#### **Understanding the Context**

In a world inhabited by over 1.9 billion young people between the ages of 10 and 24, growing most rapidly in lower income nations, the need to address their sexual and reproductive health and rights is more pressing than ever. Within this demographic, there are sexual and reproductive health challenges faced by youth of all genders, but adolescent girls have unique needs, aspirations, and compounding challenges.

Investing in the sexual and reproductive health needs of young people as they are developing their behaviors and attitudes during adolescence will have a longterm impact on the adults they will become and the families they may ultimately form.

## The Imperative for Action

To achieve the Sustainable Development Goals (SDGs), it is imperative to meet the sexual and reproductive health needs of adolescents and youth. Despite extensive efforts, substantial unmet needs persist among adolescents and youth, especially in terms of contraception. According to the Guttmacher Institute, adolescents aged 15-19 years in LMICs had an estimated 21 million pregnancies each year, of which approximately 50% were unintended and which resulted in an estimated 12 million births. FP2030 commits to addressing these needs with a multi-faceted approach. This strategy ensures that the voices, needs, and preferences of adolescents and youth are at the forefront of our actions, emphasizing inclusivity, empowerment, and progress.

## Vision and Guiding Principles

Our vision is to ensure adolescents and youth are equipped to make informed decisions about their sexual and reproductive health, supported by a dynamic and responsive ecosystem that prioritizes their needs.

#### **Guiding Principles**

The following values and principles will guide the FP2030 approach, preventing ad-hoc or poor-quality partnerships with young people and instead building sustainable partnerships and a more effective movement.

## FP2030 will be intentional in collaborating with adolescents and youth as equal partners:

Adolescents and youth remain at the heart of our strategy, actively participating in decision-making processes that affect their lives.

• FP2030 will build open, collaborative, and transparent relationships:

FP2030 will transparently share any information needed for young people to lead or collaborate in decision making.

- Our work will build on foundations of equity and human rights: FP2030 aims to ensure that every individual, regardless of background, age, sexual orientation, marital status, physical ability, or any other identity, has equitable access to reproductive health services. This is the bedrock of our approach.
- Our approach is intentionally genderresponsive, acknowledging and addressing gender-specific challenges to equitable youth leadership and in accessing sexual and reproductive health services
- Our strategy is rooted in evidence-based approaches, grounded in research and empirical insights to drive meaningful change.
- FP2030 will hold itself and our partners accountable for family planning and related programs' quality. This will be done through deep relationships with youth-led organizations and Civil Society Organizations broadly and self-reporting systems.
- FP2030 will build a more inclusive and diverse network of commitment makers and other partners, with an eye toward race, gender, ethnicity, nationality, educational attainment, socioeconomic status, language, physical ability, age, religious background, or political perspective.

## Five Pillars of Action

**Showcasing High-Impact Service Delivery Models:** FP2O3O will identify, disseminate, and advocate for innovative service delivery models tailored to AY SRHR needs. By building alliances with governments, civil society organizations, and youth-led organizations, and sharing high impact practices (HIPs), we aim to enhance service quality and delivery across the globe.

**Prioritize Adolescents and Youths in Country Commitments, Programs, and Policies:** We will ensure AY receive priority in global, regional, and national FP/SRH commitments and programs. By engaging with stakeholders, governments, and youth-led organizations, we intend to effect change at multiple levels, with youth participating in policy development and implementation.

**Data-Driven Decision-Making:** Data is at the core of our strategy. FP2030 will promote innovative data collection models, analysis, and utilization to inform policies and initiatives. We will also encourage data disaggregation to ensure that age-specific and essential AY indicators are considered.
