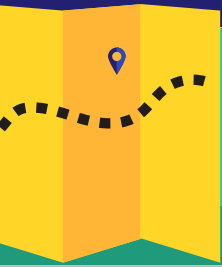

FP2030 Commitment



THE PHILIPPINES' FAMILY PLANNING VISION FOR 2030:

By the end of 2030, all Filipinos enjoy a healthy and productive life and are empowered to make informed decisions in family planning (FP) and in their reproductive health and rights.



1. Full and effective implementation of the country's Universal Health Care (UHC) Law, along with the Reproductive Health (RH) Law guarantees all Filipinos equitable access to quality and affordable health care services, including family planning (FP) and adolescent reproductive health (ARH) and protection against financial risk especially the poor, vulnerable and underserved populations.

Strategies to meet this policy commitment:

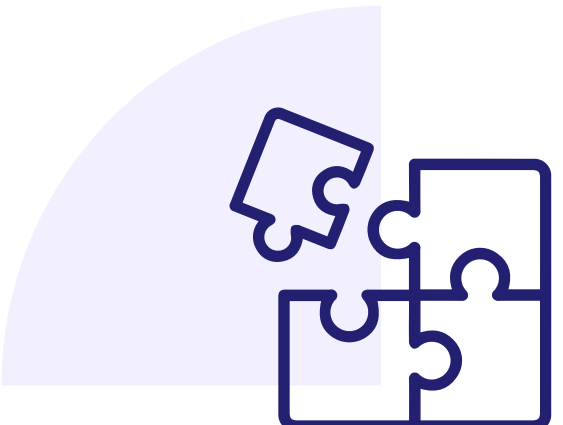
1. Collaboration with NGAs on socio-economic development and climate change
2. Integration of policies and standards that will address the high incidence of teenage pregnancies
3. Strengthening the capacity of the province- and city-wide health systems
4. Availability of a wide range of modern contraceptive methods
5. Facilitating the approval and registration processes of contraceptives by the FDA and HTAC
6. Capacity building on rights-based FP services, Minimum Initial Service Package for SRH
7. Adequate human resources for health and population work
8. Prioritizing investments in GIDAs to expand access



2. Provide access to FP information and services to all women, men, boys, and girls regardless of marital, socioeconomic status, religion, ethnicity, access to FP in any situation such as during health emergencies and disasters to achieve an 85 percent demand satisfied with modern FP methods by the year 2030.

Strategies to meet this policy commitment:

1. Integrating FP with other basic services (e.g., maternal care, immunization, pre-marriage counseling, post-abortion care)
2. Strengthening supply chain management (eLMIS)
3. Expanding FP service coverage through community-based distribution, task-shifting, and outreach
4. Social and Behavioral Change Communication (with HPB's Todo Pito)
5. Priority strategies in preventing adolescent pregnancies (e.g., CSE, AFHF, PYP, Social Protection Program for teen moms)





FINANCIAL OBJECTIVE: TO ENSURE AND INCREASE DOMESTIC FUNDING FOR THE FP PROGRAM

The Philippines will ensure and increase domestic funding for the family planning program. At least US\$ 20 Million will be allocated and spent annually by the national government.

Strategies:

1. Ensuring local financing for FP (e.g., DTP, SHF, GAD budget)
2. FP funds to bolster emergency preparedness and response (MISP)
3. Ensuring the efficiency of the government processes in supply chain management
4. Exploring strategic procurement reforms
5. Expanding the current benefit packages for FP

Approach to Accountability



The Philippines Focal Points will utilize the National Implementation Team (NIT) for RH law, a coordinating body composed of various national government agencies, CSOs, development partners, and advocates working in RH, to solicit support and push for the achievement of these commitments. Progress of these commitments will also be included in the RH law report being submitted annually to the Office of the President, Senate, and House of Representatives of the Philippines, and uploaded on the website of the DOH accessible to the general public.

COMMITMENT PRINCIPLES:
