# **Art Contest:**

**Creative Expressions about HIV** 

### HISTORICAL CONTEXT

More than 40 years after the first case of AIDS, the Human Immunodeficiency Virus (HIV) remains one of the main global public health concerns. According to UNAIDS, by the end of 2022, approximately 39 million people were living with HIV worldwide. Despite significant advances in treatment and the prevention of new infections, challenges persist, especially in terms of stigma, discrimination, and equitable access to healthcare, education, housing, and social security.

Art, as a form of expression, has a unique power to raise awareness, educate, and mobilize people. Through this contest, the goal is to raise awareness about HIV and break social barriers, while also promoting an inclusive agenda that fosters understanding and inclusion of what it means to live with HIV more than 40 years after the first case of AIDS.

### **OBJECTIVE**

The Art Contest: "Creative Expressions about HIV" aims to encourage artistic creation that reflects the reality of living with HIV, the social and personal challenges faced by those living with the virus, and the importance of prevention, respect for human rights, and access to sexual and reproductive health services.

## WHO CAN PARTICIPATE?

Adolescents, young people, and adults between the ages of 15 and 90, residing in Latin American and Caribbean countries.

The categories in which participants can compete are:

Category A: People between 15 to 35 years of age

Category B: People with 36 years of age and onwards

# **CATEGORIES**

- 1. Painting: Works that use traditional media such as oil, acrylic, watercolor, etc.
- 2. Photography: Images that capture moments, people or ideas related to HIV.
- 3. **Digital Illustration:** Works that use digital technologies to communicate a message about HIV.
- 4. Performance Video Art: Video artistic expressions or recordings featuring performances around HIV issues (a maximum of 3 minutes).

# REQUIREMENTS TO PARTICIPATE

- 1. Participants **must complete a training process** before submitting their artwork (more information on the next page).
- 2. The contestant or a legal guardian must follow @FP2030LACHub on Facebook and Instagram.
- 3.A participant can submit art in **two** categories.
- 4. Remember that the material you submit **must be entirely your own work and 100% original.** Ideally, you should do it on your own with minimal help from an adult. We know you're very talented, and we can't wait to see your creations in action!

- 5. The submitted works must be original, unpublished, and must not have been previously awarded in any other competition. If the contestant submits the same work to another contest and it is eventually awarded, the contestant is obligated to inform about this situation.
- 6. The works **must be submitted in high resolution** and in digital format (JPG, PNG, MP4, etc.).
- 7. The contestant must complete and scan the registration form attached to this document.
- 8. The work must be submitted via the contest's **Google Form.** This form will require you to include the name of your work and a brief description (maximum 400 words) explaining the meaning of the piece and how it relates to HIV.
- 9. Three files must be submitted via the Google Form:
  - The artwork
  - The properly completed registration form (Annex 1)
  - The image use consent form (Annex 2).
- 10. Works will be accepted starting from October 24, 2024, until November 24, 2024, at 11:59 p.m. (Panama Time, ET).
- 11. The winners will be announced as soon as possible.
- 12. The winning participants will receive the following prizes:





# **PRIZES**

First place in categories A and B: A laptop and the publication of their artwork on the social media platforms of Family Planning 2030 Latin America and the Caribbean Hub.

Second place in categories A and B: A mobile phone and the publication of their artwork on the social media platforms of Family Planning 2030 Latin America and the Caribbean Hub.

Third place in categories A and B: A pair of headphones and the publication of their work on the social media platforms of Family Planning 2030 Latin America and the Caribbean Hub.

#### TRAINING PROCESS

### **POSSIBLE THEMES**

- HIV Awareness: Promote education about HIV, its modes of transmission, and prevention methods, as well as awareness of living with HIV.
- Stigma and Discrimination: Barriers and challenges to equal access to education, employment, housing, social security, and all rights.
- Access to Treatments and Health Services: Highlighting the importance of access, continuity, and adherence to antiretroviral treatments, and what comprehensive care for people with HIV means.
- Human Rights: Advocate for equal rights for people living with HIV and the elimination of legal and social barriers.
- Combined Prevention: Reflect on the use of prevention methods such as condoms, PrEP, PEP, and comprehensive sexual education (CSE).

# **CAUSES FOR REJECTION**

- 1. For being submitted outside the established deadlines.
- 2. For being outside the age limit.
- 3. If the work is awarded or published during the period of the "Art for Sexual and Reproductive Rights" Contest; that is, from the opening date of the call until the date of the award.
- 4. If partial or total plagiarism of the submitted work is detected, or any other violation of copyright regulations.
- 5. If the work violates good values and/or its content is offensive or inappropriate.
